Notice of Execution of Hotel Management Contracts and Revenue Guarantee Contracts for Five Hotels

KACHIKAIHATSU Co., Ltd. (hereinafter, "Polaris Holdings") announced today that KOKO HOTELS Co., Ltd., which is a subsidiary of Polaris Holdings, decided to execute a hotel management contract (hereinafter, the "Hotel Management Contract") and to commence management of five hotels under Polaris Group's new brand KOKO HOTELS. In addition to the Hotel Management Agreement, KOKO HOTELS Co., Ltd. decided to execute a revenue guarantee contract (hereinafter, the "Revenue Guarantee Contract") with the sponsor group enterprise of Polaris Holdings under which if the revenue from the hotels under management is less than the operating expenses, such operating expenses and management fees shall be covered by the sponsor group enterprise. Details are as follows.

1. Conclusion of the Hotel Management Contract

(1) Events leading to the Hotel Management Contract

As stated in "Notice of Execution of MOU to Manage Five Hotels" released on September 30, 2020, Polaris Group executed a Memorandum of Understanding on the Hotel Management and held discussions with Star Asia Group, the sponsor of Polaris Holdings, in anticipation of concluding a hotel management contract with respect to UNIZO INN Sapporo, UNIZO Ginza-itchome, UNIZO INN Hiroshima Ekimae, HOTEL UNIZO Fukuoka Tenjin, and UNIZO INN Express Kagoshima Tenmonkan (hereinafter the "Property Portfolio"). Polaris Group has now executed a hotel management contract in which Polaris Group is named as hotel operator for the Property Portfolio and will commence operation sequentially from October 14, 2020.

(2) New hotel brand KOKO HOTEL

As stated in the KACHIKAIHATSU Growth Strategy Plan (Fiscal Year Ending March 2021 to Fiscal Year Ending March 2022) released on August 7, 2020, the Polaris Group has been examining the launch of a new hotel concept, aimed at creating high-tech hotels that utilize both AI and IT to achieve efficient hotel management. As part of the realization of this hotel concept, the Polaris Group has launched KOKO HOTELS as a new internally developed brand and to market this brand as a Group in the future. The Property Portfolio hotels will be the first hotels under Polaris Group's original brand. These KOKO HOTELS are all located in convenient locations in major Japanese cities and will tap into both business and tourism demand in their respective submarkets, and can be expected to contribute to the Polaris Group's sustainable profit growth.

The execution of the contract to manage the Property Portfolio will increase the total number of hotels managed by Polaris Group to 31 with 5,199 guestrooms. This transaction will increase the number of properties under management by 19.2% and the number of guestrooms by 31.1%, respectively.
